Key Points

- 1750 potential victims were submitted to the National Referral Mechanism during the period July to September 2018; a six percent increase from the previous quarter April to June 2018.
- Reporting showed potential victims of trafficking originating from 85 different countries this period.
- Nationals from Albania, the United Kingdom and Vietnam remain the most commonly reported, with the UK being the most referred for the fourth consecutive quarter.
- The most recorded exploitation type for potential victims exploited as an adult was labour exploitation.
- The most prominent exploitation type recorded for potential victims first exploited as a minor was labour exploitation, which includes criminal exploitation such as cannabis cultivation and County Lines drugs supply.
- Two cases this quarter relate to organ harvesting referrals. Both cases are under consideration for their conclusive grounds decision, with neither case having any alleged harvesting or trafficking within the UK. Further enquiries will be necessary in one case to determine whether harvesting has actually taken place during the potential victim's migratory journey to the UK. No harvesting is said to have occurred in the second case.
- Over 30% (524) of referrals received this quarter had no claimed exploitation within the United Kingdom, with a further 11% (193) where no location was identified.
- The Police Service of Northern Ireland received 17 referrals for crime recording purposes, with 64 referred to Police Scotland and 66 referred to Welsh forces. The remaining 1603 were referred to police forces in England.

National Referral Mechanism Statistics – 2018 Quarter 3

This report presents a summary of the number of potential victims of modern slavery and human trafficking referred in to the National Referral Mechanism (NRM) during the period 1st July to 30th September 2018.

The figures used are from the NRM data with a cut-off date of 11/10/2018. Many of the cases remain open with the Competent Authorities and decisions on their trafficking status are yet to be made. The NRM is a 'living' process and data should be considered provisional until all cases are concluded. Some values may differ from previous or future reports as supplementary information is revealed throughout the duration of a case and their records are adjusted accordingly.

Percentages are rounded to the nearest whole percentage point.

This report does not provide any analysis of the picture of modern slavery in the UK.

The report provides figures relating to the number of potential victims that have been referred in to the NRM process during the reporting period July to September 2018, with no decision data for the case.

Changes Introduced to NRM Data Management

Previous iterations of this report were produced on the basis of the police force and country location of the first responder, irrespective of the claimed location of exploitation or residence of the potential victim at the time of referral. This led to invalid hotspot analysis of the data being applied to police force areas and the devolved regions of the UK.

Following the July 2016 clarification and subsequent update in July 2017 within the Home Office Counting Rules¹ (HOCR) whereby:

“all referrals made by the police into the NRM and all those that the police receive from the NRM with a positive reasonable grounds decision applied must be subject of a recorded crime of MS (modern slavery)”

A subsequent NCA review established that the previous statistical attribution of referrals to a particular country within the UK on the basis of the location of the first responder was misleading.

In support of HOCR requirements, NRM referrals are now screened against the below criteria in order to identify the responsible geographical police force. Once identified, the referral is transmitted within one working day to the relevant Force Intelligence Bureau (FIB), or stipulated point of receipt within force for action. The reasonable grounds decision, once made, is subsequently notified to the force by the competent authority.

Criteria applied to identify relevant force

The force has acted as first responder, or the referral indicates that the force is already involved in the recording/investigation of the potential modern slavery human trafficking (MSHT) offences;

or

The potential victim has been exploited within the force area;

or

The potential victim has been exploited abroad, or at an unknown location and the victim's address at time of referral is within the force area;

or

The potential victim has been exploited abroad or at an unknown location and they have presented to another first responder within the force area.

The Annexes to this report and table overleaf have been compiled on the basis of where the police force that received the NRM referral for crime recording is located, e.g. Wales will be comprised only of NRM referrals originating from, or sent to Dyfed-Powys Police, Gwent Police, North Wales Police or South Wales Police.

The Annexes do not reflect where the initial force has subsequently transferred the crime recording responsibility to another force.

NRM Statistics Quarter 3, July – September 2018

In this quarter, the UK National Referral Mechanism (NRM) received 1750 referrals of potential victims (PV); this represents a six per cent increase on the previous quarter. The PVs were reported to be of 85 differing nationalities.

The 1750 referrals were comprised of 645 females (37%) and 1105 males (63%). Referrals for 981 (56%) for adult exploitation categories and 769 (44%) referred for exploitation as a minor were received.

Annex A - ENGLAND – 2018 Quarter 3

In Quarter 3 2018, the UK National Referral Mechanism (NRM) received 1603 referrals of potential victims (PV) where the referral was subsequently sent to a police force for crime recording considerations in England; this represents 92% of all UK referrals to the NRM.

The 1603 referrals were comprised of 589 females (37%) and 1014 males (63%). There were 884 (55%) individuals referred for adult exploitation categories and 719 (45%) referred for exploitation whilst a minor.
