Key points

- 895 potential victims were referred in to the National Referral Mechanism during the period January to March 2016; a 5% decrease on the previous quarter October to December 2015.
- Potential victims of trafficking were reported of 88 different nationalities
- Albania, Vietnam and China are the most common nationality of potential victims referred.
- The most common exploitation type recorded for potential victims exploited as an adult was labour exploitation, which also includes criminal exploitation.
- The most prominent exploitation type recorded for potential victims first exploited as a minor where known, was labour exploitation, which includes the sub category of criminal exploitation.
- 11 people were referred from Northern Ireland, 29 from Scotland and 35 from Wales. The remaining 820 were referred in England.

National Referral Mechanism Statistics – 2016 Quarter 1

This report presents a summary of the number of potential victims of modern slavery referred in to the National Referral Mechanism (NRM) during the period January to March 2016.

The figures used are from the NRM data with a cut off date of 06/04/2016 . Some of the cases have yet to be concluded by the Competent Authorities and decisions on their trafficking status made. The NRM is a 'living' process and data should be considered provisional until all cases are concluded. Some values may differ in future reports, or from previous reports as additional information comes to light through the duration of the cases and the records are amended accordingly.

This report does not provide any analysis of the picture of modern slavery in the UK. It provides figures relating to the number of potential victims that have been referred in to the NRM process during the reporting period January to March 2016, but does not contain decision data for the year to date due to the number of pending cases.

NRM Decision Data - 2015

This report contains limited decision data for 2015 cases, which will be updated each quarter.

In summary, as at 06/04/2016, of the 3266 referrals to the NRM in 2015:

- 963 (29%) had received negative decisions (reasonable grounds or conclusive decision);
- 871 (27%) of cases received a positive conclusive decision;
- 117 (3.5%) of cases were suspended;
- 83 (2.5%) of cases were withdrawn; and
- 1232 (38%) of cases are pending a decision (reasonable grounds or conclusive decision).

Of the 1834 cases to have received a final decision, 53% were negative and 47% were positive.

A breakdown of 2015 NRM decisions by nationality, reasonable grounds and conclusive decision can be found at Annex G.

NRM Statistics Quarter 1 January - March 2016

In this quarter, the UK National Referral Mechanism (NRM) received 895 referrals of potential victims (PV); this represents a 5% decrease on the previous quarter. The PVs were reported to be of 88 differing nationalities.

The 895 referrals were comprised of 450 females (50%) and 442 males (49%) and three (<1%) recorded as transgender. 613 (68%) were referred for adult exploitation categories and 282 (32%) referred for exploitation as a minor.

Annex A - ENGLAND - 2016 Quarter 1

In Quarter 1 2016 the UK National Referral Mechanism (NRM) received 820 referrals of potential victims (PV) first encountered in England; this represents a 2% decrease on the previous quarter and 92% of all UK referrals to the NRM.

The 820 referrals were comprised of 411 females (54%), 406 males (46%) and three (<1%) were recorded as transgender. 554 (68%) referred for adult exploitation categories, 266 (32%) being referred for exploitation as a minor.

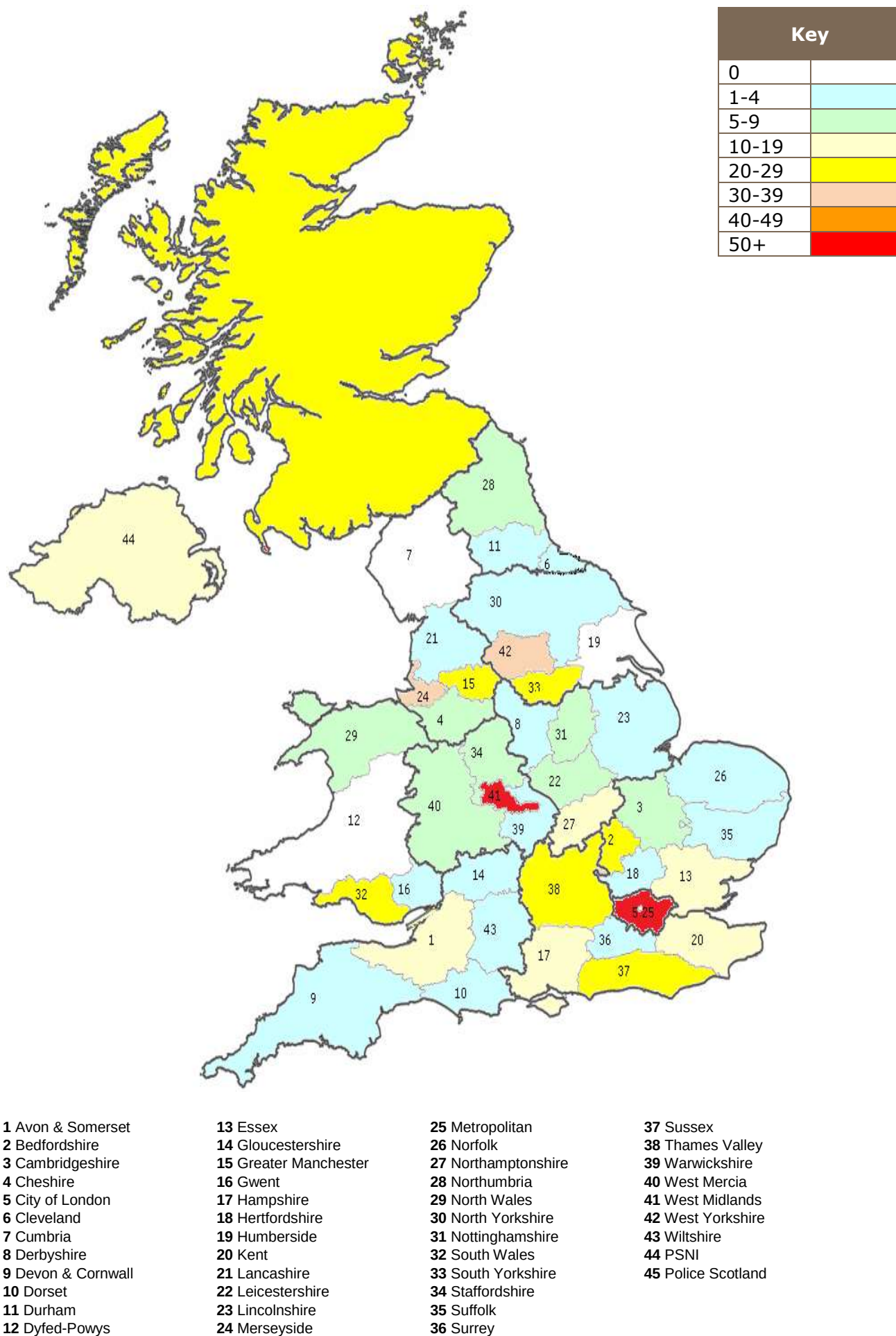
